



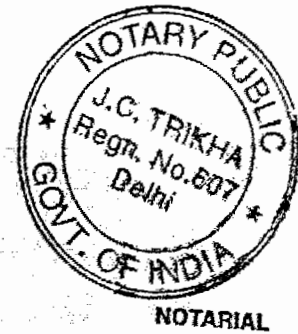
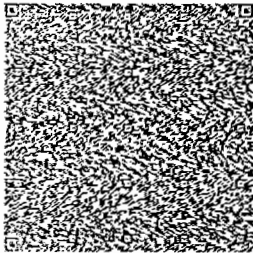

I, the above named deponent, do here by solemnly affirm and declare as under :

1. That I am the Director in the above company and as such am well conversant with the functioning of the company and state on Oath/ depose this affidavit.
2. That the establishment of the deponent M/s Sun Operation and Maintenance Engineering Pvt. Ltd. (hereinafter referred to as the contractor) is an independent legal identity and contractor in accordance with the provisions of the Contract Labour (Regulation & Abolition) Act, 1970, having its employees deployed 64Nos. of employees at the premises of M/s Surya Maintenance Agency Pvt. Ltd. (hereafter referred to as the Principal Employer) to carry out Facility Management work at City Centre Mall, Plot No.1B- 3, Twin Distt. Centre, Sector-10, Rohini, Delhi.
3. That the deponent has entered in to an agreement with M/s Surya maintenance Pvt. Ltd. On 24.09.2018 to carry out above work which shall remain in force from 1st October, 2018 to 30th September, 2019.
4. That those workers deployed by the Deponent and performing the same and similar kind of work has been done by the workers directly employed by the principal employer are being paid the same wages as applicable to the directly employed workers of Principal Employer.
5. That the deponent undertake that each and every worker deployed by the deponent is being paid not less than the minimum rates of wages fixed for the their category of employment from time to time by the Govt. of NCT of Delhi under the provisions of Minimum Wages Act, 1948 including Over time/weekly off etc.it shall be paid through Account Payee Cheque/ECS/Bank Transfer. The payment of wages will be made in the presence of Authorized representative of Principal Employer, and duly verify by him.
6. That the establishment of the deponent is providing all statutory benefits and maintaining the records under the applicable Labour Laws in respect of all the workers deployed in the premises of the principal employer.
7. That the process on which the contract workers are deployed is not abolished by any Authority or board under the provision of contract labour (R&A) Act, 1970
8. That the Deponent has uploaded the required information and documents as per check list in their website www.sunoperations.com and the website is not be password protected and will be updated every month, further the required information and documents shall not be removed from the website without prior permissions and changed, if any shall be intimated to the Licensing Officer.

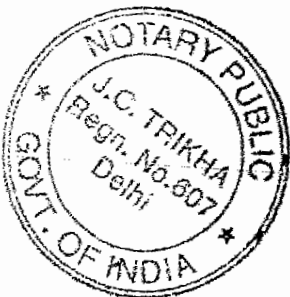
